



## **Call to SVAN Artists to Participate in the Sacandaga Valley Arts Network Artists' Gallery**

*Located inside the Fulton County Visitor Center, Vail Mills  
At the intersection of NYS Rt. 29 & 30*

### **OPPORTUNITIES FOR SVAN VISUAL ARTISTS in VAIL MILLS at the FULTON COUNTY VISITOR CENTER GALLERY**

The Sacandaga Valley Arts Network (SVAN), serving the region's growing arts community, in conjunction with the Fulton Montgomery Regional Chamber of Commerce, opened a gallery in the Fulton County Chamber Visitor Center at Vail Mills in June 2009. We are offering SVAN visual artists the opportunity to display their work in the gallery.

#### **OVERVIEW of PURPOSE**

SVAN requested and was granted permission to use available space in the Visitor Center as a SVAN Art Gallery. Displaying a diverse selection of artwork in the center, located at the junction of Rt. 29 and Rt. 30, will accomplish several important community goals—

- Promote the arts by expanding the awareness of SVAN to the larger community
- Provide a networking vehicle for artists
- Provide an opportunity for increased art sales by exposure
- Because of its location, the Art Gallery will attract out of town as well as local residents to the center
- The Visitors Center will be a destination for information about SVAN Classical Concerts, Musical Theater, Art Exhibits, Workshops, and wide array of Musical Performances

#### **MANAGEMENT, SPACE USAGE and FEES**

The Gallery displays artwork by SVAN artists with a periodic rotation. Artwork in the gallery can be purchased at any time it is open from the Fulton County Visitor Center employee on duty. An annual fee of \$10 for participation in this program will be charged. This fee is separate from and in addition to the SVAN annual membership fee. The fee will help cover gallery space improvements, advertising and signage. There is no commission charged for work sold.

#### **INSURANCE**

Each artist will be responsible for insurance on his/her artwork. The artist bears the risk of loss for artwork offered for display and neither the Chamber nor SVAN will be liable for the artist's artwork or personal injury. SVAN will require a signed inventory list of all titles, media and prices when an artist's work is delivered to the Visitor Center Gallery.

#### **MEMBER PARTICIPATION**

**Artists wishing to participate at the gallery must be a SVAN member.** SVAN membership information is available on-line at <https://www.svanarts.org/membership>. A participating artist may display two framed pieces ***ready to be hung with wire***. Locked glass cases are available for the display of small 3-dimensional items— two pieces per person.
